9 REQUIREMENT STATE FOR DATA ELEMENTS

Table 1 provides the requirement state for individual data elements for Base documents within the new Grants module. Data elements that shall pre-populate when an existing record is referenced are detailed under the pre-population column.

For Recipient Information, on a pre-populated document, if the DUNS No. is changed, the recipient information associated with the new DUNS No. shall populate the recipient information data elements.

The pre-population feature is only available through the Web Portal.

Key- For Table 1

- “Required”- indicates that the data element is a mandatory field
- “Optional”- indicates that the data element is not a mandatory field
- “Enter”- indicates that the Grants Specialist will input this information
- “Pre-populate”- indicates that the value shall be pre-populated from the referenced document
- “System generated field” or “System Derived”- system shall auto generate the value
- “Grant Specialist”- user with the assigned access and privileges to the Grants module.
